MUGA

By completing a Booking and Paying for the Booking you agree to the following MUGA Hire Conditions and any subsequent replacing Hire Conditions which will be notified to you in advance.

MUGA HIRE CONDITIONS

Expressions - Unless the context requires otherwise the masculine includes the feminine and vice versa and the singular includes the plural and vice versa.

DEFINITIONS

MUGA - The area enclosed by tall green metal fencing inclusive of built in goals and basketball nets. This does not include the adjacent Seating Area.

FLOODLIGHTS - the lights around the perimeter of the MUGA which will operate during the BOOKING dependent on daylight conditions.

CPRGT - Chilham Parish Recreational Ground Trust.

HIRER –The Organisation or Person hiring the MUGA, one of whom is an adult, aged at least 18 years old, who is responsible for the persons using the MUGA and who will be present during the BOOKING.

BOOKING - The period for which the HIRER has paid the FEE.

FEE - The amount paid to CPRGT for the BOOKING using the CLUBNET Booking System.

USAGE

CPRGT reserves the right to have first use of the MUGA on any specified day and will give at least 14 days notice to HIRERS who may be directly affected.

The HIRER must leave the MUGA promptly at the end of the BOOKING otherwise an additional FEE may be due.

The HIRER agrees that the time required to set-up and remove equipment from the MUGA is considered part of the BOOKING.

The HIRER agrees that the MUGA will only be used for ball or sporting exercise related activities and no wheeled vehicles of any description will be allowed in the MUGA

MUGA

Any damage or breakage is chargeable to the HIRER.

The HIRER must not carry out or make arrangements to carry out any alterations or additions to the fabric or surface of the MUGA.

The Hirer must not transfer the Booking to any other person or persons

The number of persons in the MUGA must not exceed 20

All rubbish is to be removed from the MUGA and put in the bins provided

The MUGA must be left in a clean and tidy condition

To avoid disturbing neighbouring properties, noise must be kept to acceptable levels

Alcohol is strictly not allowed inside the MUGA or the Recreation Ground

BOOKINGS AND PAYMENT

BOOKINGS and payments of the FEE are only accepted through the online Clubnet Booking System

The MUGA is an outside Sports facility so subject to usual weather conditions. Refunds will only be given in exceptional circumstances or if the Booking is cancelled at least 24 hours before the Booking

CHILD PROTECTION AND CARE OF VULNERABLE ADULTS

The HIRER confirms that he is familiar with the Home Office Code of Practice "Safe from Harm" and "The Protection of Children Act 1999" (or any replacing Statutes or Guidelines). The HIRER understands these policies and procedures and undertakes to follow their recommendations in relation to work with children, young people of 17 years and under and vulnerable adults.

The HIRER agrees that only leaders and helpers recruited following the "Safe from Harm" and the "Protection of Children Act 1999" (or any replacing Statute or Guidelines) recommendations will be working with these children, young people and vulnerable adults.

The HIRER confirms that all adults have been checked by the Disclosure and Barring Service (DBS) and have been issued with a confirmation number.
